# TAX

## IDENTIFICATION NUMBER FOREIGNERS IN TURIN

**Simple Tips**  
*to those applying for a residence permit or international protection*

The tax identification number (TIN) is assigned :

⇒ To those applying for a residence permit for employment or family reunification, through the **Immigration Desk** of each Prefecture (responsible for issuing the authorization for entry). Initially, a temporary numerical code is provided. The definitive TIN (made up of letters and numbers) is issued along with the residence permit .

⇒ To those applying for other types of residence permits, through the **Questura**, an office of the State Police.

⇒ To those applying for international protection, through the **Questura** or **Border Police** at the time of the request .

### SPECIAL CASES

If two or more individuals have **personal data that generate the same TIN**, the Questura issues a temporary code and advises the individual to visit any office of the Revenue Agency ("Agenzia delle Entrate") to obtain the definitive one .
